### Theme

Inspired and sponsored in part by artist Michi Susan, this Paseo Arts Association juried exhibition CHALLENGES artists to create a mixed media, three-dimensional container of some type. The judge will look at originality and how well the artist interprets the idea of containment.

### Specifications

Open to all 3D work of any media; the work must include at least two disparate media. The size limitation is up to 24” in any direction. Size limitations will be enforced. Work presented for the exhibition must be ready for display on wall or pedestal.

### Eligibility

Oklahoma artists 18 and older.

### Awards

Best of Show \$200  
Two Awards of Merit at \$100  
Two Honorable Mention Awards at \$50  
Judge will assign awards.

### Judge

Clint Stone is the Artistic Director for the City Arts Center and an accomplished artist. He holds a Bachelor of Arts Degree from the University of Central Oklahoma and one of his paintings was recently featured on the cover of “Oklahoma Today” magazine.

## Entry Procedure

Entries will be selected from ACTUAL work. Artist may submit up to two pieces for a non-refundable fee of \$20 for Paseo Arts Association members and \$25 for non-members.

Work is to be delivered to Paseo Art Space, 3022 Paseo, Oklahoma City, between Wednesday, October 21 and Saturday, October 24, noon-4 pm. Work not juried into the exhibition must be picked up Saturday, October 31 or Wednesday, November 4 between noon and 4pm. You will be notified by email or phone.

PAA retains 30% commission on all works sold. Price accordingly. All work must be for sale.
